General Terms and Conditions of Continuing Education Seminar Registration and Attendance

- The seminar organizers are not liable for the accuracy/veracity or applicability of learning content imparted by seminar instructors.
- Seminar enrollees shall only be entitled to reimbursement of seminar fees paid in the event a continuing education course should have to be canceled on short notice due to illness on the part of the seminar instructor, insufficient enrollment or other reasons beyond the control of the seminar organizers. Any further claims shall be excluded, irrespective of any other costs incurred by seminar enrollees due to patient appointment cancellations, booking of accommodations, travel costs etc.
Seminar enrollees shall be liable for payment of the seminar fee regardless of any seminar fee supplements or defrayments applied for (unemployment office, education credits etc.).
- Seminar enrollees canceling their registration to attend a continuing education seminar – for any reason whatsoever – shall be entitled to reimbursement of the enrollment fee as follows:
100% if canceling more than 8 weeks prior to seminar begin;
50% if canceling 4 – 8 weeks prior to seminar begin;
30% if canceling 2 – 4 weeks prior to seminar begin.
The entire seminar fee is payable for cancellations on any shorter notice. No claim accrues in such case to reimbursement of seminar fees paid. You may attempt to contest the amount of damages incurred by us in a specific case on the basis of documentation. That is not possible to cancel enrollment in specific segments of seminars that are conducted in segments! The entire seminar fee is due in the event of non-attendance.

Right of withdrawal for consumers

Consumers have a 14-day right of withdrawal.

Right of withdrawal

You have the right to revoke this contract within fourteen days without giving any reasons. The revocation period is fourteen days from the date of conclusion of the contract.

In order to exercise your right of revocation, you must notify us (FiHH Das Fortbildungsinstitut Harste-Westendorf GmbH & Co. KG,, Wandalenweg 14-20,20097 Hamburg, Fax: 040 234522, E-mail: info@fihh.de) by means of a clear declaration (e. g. a letter, fax or e-mail sent by post) of their decision to revoke this contract. In order to comply with the revocation period, it is sufficient that you send the notice of revocation prior to expiry of the revocation.

Consequences of the revocation

If you revoke this contract, we will refund all payments received from you immediately and within 14 days from the date on which we receive notice of your revocation of this contract. We will use the same means of payment for this repayment as you used in the original transaction, unless otherwise expressly agreed with you; in no case will you be charged for this repayment. If you have requested that the services should commence during the withdrawal period, you must pay us a reasonable amount corresponding to the proportion of services already provided up to the time you notify us of the exercise of the withdrawal right with respect to this contract as compared to the total amount of services provided in the contract.
